



VISION, MISSION AND COMMITMENT TO STAKEHOLDERS

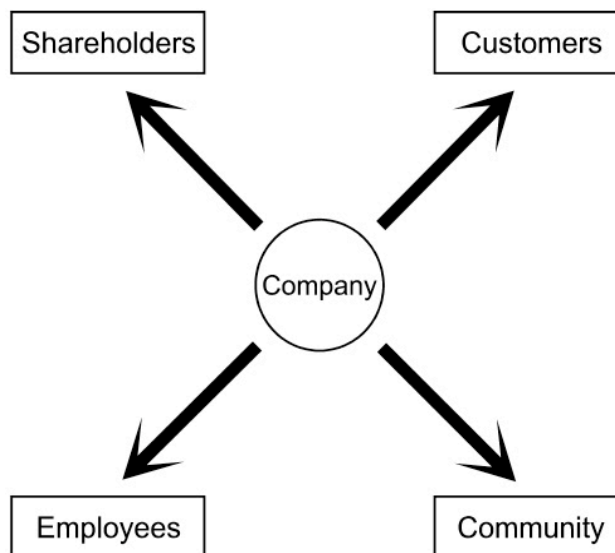
